FAMILY PARTICIPANTS RELEASE OF LIABILITY & ASSUMPTION OF RISK

READ BEFORE SIGNING

In consideration of me, my spouse, my children/wards, or any other family member ("Family") being allowed to participate in any way in the events and activities of New Life Ranch, the undersigned acknowledges, appreciates, and agrees that:

The risks of injury and illness (ex: communicable diseases such as MRSA, influenza, and COVID-19) to the Family Participants from the activities involved in these programs are significant, including the potential for permanent disability and death, and while particular rules, equipment, and personal discipline may reduce these risks, the risks of serious injury and illness do exist; and,

I am aware that the activities at New Life Ranch will necessarily involve participation in exercises which by their nature may be considered inherently dangerous and physically demanding and may subject the Participant to stress, anxiety, illness, injury and other hazards, not all of which can be foreseen. It is fully understood that the Participant may participate in activities, including but not limited to, climbing and walking on cables, logs, ladders, walls, and beams, some of which may be at substantial heights above the ground; hiking across undeveloped steep terrain some distance from emergency services; aquatic, lake and river activities; horsemanship; target sports; mountain biking; and physically interacting with plants and animals in the forest, grassland, and waterways of New Life Ranch.

I acknowledge that although New Life Ranch has taken safety measures to attempt to minimize the risk of injury to participants, New Life Ranch cannot ensure nor guarantee that the participants, equipment, premises and/or activities will be free of hazards, accidents and/or injuries.

FOR MY FAMILY, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, and assume full responsibility for my Family's participation; and, willingly agree to comply with the program's stated and customary terms and conditions for participation. If I observe any unusual significant concern in my Family's readiness for participation and/or in the program itself, I will remove my Family from the participation and notify New Life Ranch; and, I for myself, my Family, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS New Life Ranch; its directors, officers, officials, agents, employees, volunteers, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("Releasees"), with respect to any and all injury, illness, disability death, or loss or damage to person or property incident to my Family's involvement or participation in these programs to the fullest extent permitted by law. I, for myself, my Family, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY INDEMNIFY AND HOLD HARMLESS all the above Releasees from any and all liabilities incident to my involvement or participation in these programs to the fullest extent permitted by law. I, the parent/guardian, assert that I have explained to my Family: the risks of the activity, his/her responsibilities for adhering to the rules and regulations, and that my Family understands this agreement.

I, FOR MY FAMILY, AND MYSELF HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT WE HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
